SUBJECT: Third doses of COVID-19 Vaccine for Long-Term Care Homes and
Higher-Risk Licensed Retirement Homes

We are writing in follow-up to the August 17, 2021 announcement about third doses of the COVID-19 vaccine for residents in higher-risk congregate settings, including long-term care (LTC) homes and higher-risk licensed retirement homes.

Based on the recommendation of the Chief Medical Officer of Health and health experts, the province will begin offering third doses of the COVID-19 vaccine to those at highest risk, providing them with an extra layer of protection against the Delta variant, as we face the fourth wave of the pandemic.

Residents of LTC homes and higher-risk licensed retirement homes will be eligible to receive their third dose at least five months following their second dose. Residents will receive their third dose in their residence, either within the home or through a mobile clinic.

As previously communicated, we are calling on public health units (PHUs) and homes to work together to set up homes to independently administer COVID-19 vaccines (where

they have not already done so) and begin working on administering third doses to residents as soon as possible. LTC homes with the lowest staff vaccination rates or homes that did not report their data to MLTC should be prioritized for third doses. Additionally, PHUs and homes should work together to include staff, student placements, volunteers and caregivers for first and second doses when administering resident third doses. Where homes do not have the capacity to self-administer (e.g., regulated health professionals with authority to administer vaccines are unavailable to partner with retirement homes), PHUs must continue to work with homes to identify the appropriate approach for administering third doses in homes (e.g., through the use of mobile teams). We have included the supporting materials previously shared for the LTC and retirement homes vaccine maintenance strategy, for ease of reference, as well as the updated consent form and information sheet. An updated consent form must be completed prior to administering a third dose. All homes are encouraged to gather consent forms from residents (or their substitute decision-maker), even if a date for vaccination has not been set.

As part of our efforts to continue supporting homes and PHUs and to ensure a clear understanding of home-administration, we are asking PHUs to identify which homes are currently independently administering COVID-19 vaccines by completing the attached request form for homes in your region and sending it to MLTCPandemicResponse@ontario.ca by Monday, August 30th.

We sincerely appreciate the efforts made by public health units, long-term care homes and licensed retirement homes for your successful and impactful vaccination programs, and trust in your continued collaboration to ensure a successful third dose campaign.
